Tender for Geotechnical Investigation for Proposed Middle Income Housing Project at Welisara

1. The Chairman, Department Procurement Committee (DPC) wishes call for bids for Geotechnical Investigation for Proposed Middle Income Housing Project at Welisara.
2. Project Scope:
 - Advancing 07 no's of boreholes at the site using core drilling technique to establish the surface profile at the site
 - Conducting Standard Penetration Tests (SPT) at 1.0 m depth intervals
 - Conducting laboratory tests to determine soil properties
 - Determining parameters required to calculate the bearing capacity
 - Data analyzing and preparation of the report with recommendation for foundation
3. Bidding will be conducted through the **National Competitive Bidding** procedure.

Duly filled Tender Documents shall be sent under one registered cover addressed to **Chairman, Urban Settlement Development Authority, 9th floor, Sethsiripaya, Battaramulla** to reach on or before **2.00 p.m. on 21.05.2024** or placed in the tender box made available at Urban Settlement Development Authority. The sealed cover in which the tenders are enclosed should be marked **"Tender for Geotechnical Investigation for Proposed Middle Income Housing Project at Welisara"**.

All bids shall be accompanied by a "Bid-Security, of **LKR 22,000.00** Bid Security shall be from a Commercial Bank approved by the Central Bank of Sri Lanka or from the Construction Guarantee Fund. It shall be irrevocable and unconditionally encashable upon the first written Demand from the Employer. Bid Security shall be valid up to **20.08.2024**.
